NOTICE OF GENERAL ELECTION

Revised Code, Secs. 3501.03

The Board of Elections of Allen County, Ohio, issues this Proclamation and Notice of Election.

A GENERAL ELECTION WILL BE HELD ON

TUESDAY, the 5th day of November, 2013,

at the usual place of holding elections in each and every precinct throughout the County or at such places as the Board may designate, for the purpose of choosing the following officers:

Lima Municipal Court Clerk for the unexpired term ending 12/31/2015; Lima City: Mayor, Auditor, Director of Law, 1st, 3rd, 5th, 7th Ward Council members; Delphos City: Treasurer, 1st and 2nd Ward Council Members; Members of Council: Village of Beaverdam (4), Village of Cairo (4), Village of Elida (4), Village of Harrod (4), Village of Lafayette (4), Village of Spencerville (4), Village of Bluffton (4) and Mayor for the unexpired term ending 12/31/2015. Board of Public Affairs: Village of Harrod (2) & Village of Lafayette (2). Townships: 2 Trustees each, Auglaize Township Fiscal Officer for the unexpired term ending 3/31/2016; Marion Township Fiscal Officer for the unexpired term ending 3/31/2016. Village of Harrod Tax Levy, renewal, 1.8 mills, current operating expenses, 5 years

Village of Spencerville Income Tax Levy, additional .25%, police services, continuing period of time

Jackson Township Tax Levy, renewal, .75 mill, fire and emergency medical services, 5 years

Bath Local School District Tax Levy, renewal, 11.603 mills, emergency requirements, 5 years

Elida Local School District Tax Levy, additional, 5.45 mills, emergency requirements, 5 years

Perry Local School District Bond Issue, additional, 3.55 mills, school construction, 37 years and Tax Levy, additional, .5 mill, maintaining classroom facilities, 23 years

Shawnee Local School District Tax Levy, renewal, 4.28 mills, emergency requirements, 5 years
